By completing this form and signing below, you acknowledge and agree to the following:

1. You have complied and will continue to comply with the responsible disclosure process described in the Ledger Bounty Program which includes your agreement (a) **not to disclose the security related bug to anyone** without Ledger's prior written consent, (b) **only target your own device(s)**, and (c) **not to attack or expose other users** to the security related bug to prove your point.

2. You are of legal age in your jurisdiction to enter into this agreement (or your parent or guardian is signing this agreement for you); neither you nor any immediate family member is employed by Ledger or its subsidiaries; payment of the reward to you will not violate any applicable laws; and you are solely responsible to report and pay income or other taxes, if any, that apply to your receipt of this reward.

3. You hereby grant to Ledger, its subsidiaries, affiliates and customers a non-exclusive, perpetual, irrevocable, worldwide, royalty-free, transferable, sub licensable (through multiple tiers) license to use, reproduce, adapt, modify, publish, distribute, publicly perform, create derivative work from, make, use, sell, offer for sale and import for any purpose the materials submitted by you to Ledger in connection with the security related bug you identified.

4. From time to time Ledger may decide to feature in publicity persons who have made significant contributions to the Ledger Bounty Program. If selected, and upon mutual written agreement regarding acceptable attribution (email being sufficient), you grant Ledger the right to display your name and/or attribution information on Ledger websites, in press releases, or other media. Either party may elect to no longer participate in or publish contribution information on written notice, in which case Ledger will promptly cease use of your name and attribution information in new publicity, but will not be required to recall or revise past press releases or other materials.
